PART I. General Expectations

Carver Academy Elementary agrees to implement the following statutory requirements:

PART II. Description of how Carver Academy Elementary will implement the required components of the campus Title I Parent Engagement Plan.

1. Carver Academy Elementary] will take the following actions to involve parents in the joint development of its campus Parent Engagement Plan under section 1112 of the ESEA:
 - Establish the campus Parent Engagement Advisory Council adequately represented by parents of attending children, administrators and Title I personnel. Other council members may include community members and students.
 - Annually hold a meeting to review, discuss, and revise the school's Title I Parent Engagement Plan.
 - Parents will be selected to participate in this committee at the beginning of the year via the completion of a volunteer form. Parents who filled out this form will be invited to participate. A note asking for volunteers will go home in the Take Home Tuesday folders. Phone calls and one-on-one visits with parents will also be made.
2. Carver Academy Elementary] will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:
 - Hold committee meetings, composed of parents and school staff, to review the Campus Improvement Plan.
 - An open invitation will be made to any parent who wishes to participate. The Parent Engagement Liaison will visit with parents via phone, mail or in-person (home visit) to verify if they wish to participate.
 - Provide Title I, Part A school staff support in enhancing their School Campus Improvement Plans.
 - A scheduled meeting will occur in August with teachers regarding CIP. Teachers will receive information and training regarding the CIP. Throughout the year during a scheduled staff development meeting the improvement plan will be discussed and changes added as needed.
 - Administer the Title I campus Parent Engagement Survey designed to identify the type of support, information, and resources that parents' need included in their Campus Improvement Plan and campus Parent Engagement Plan to better support their children's education and become more involved in their school.
3. Carver Academy Elementary will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in the Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting and will encourage them to attend. These informative meetings may include, but are not limited to, the following:
 - Ice Cream Social Welcome Back and Meet Your Teacher.
 - Open House tabling for parent volunteers where information will also be provided regarding Title I.

- Invitation to Monthly Meetings.
- Parents can come to the school at any time to visit with Lynne Morris-Vivens, Social Worker/Parent Engagement, regarding their concerns.

4. Carver Academy Elementary will, in a timely manner, provide parents of participating children information about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet:

- Parents receive progress reports every three weeks. Every six weeks a report card goes home in the Take Home Tuesday Folder. On the 2nd grade report cards a separate form is attached with the reading level of the student.
- 3rd, 4th, and 5th grade teachers will send home information in Take Home Tuesday folders regarding academic growth and where the student is expected to achieve.

5. Carver Academy Elementary will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible. These may include, but are not limited to, the following:

- Suggestion may be sent or called in to Lynne Morris-Vivens or made during scheduled PI meetings.
- Parent Surveys
- Monthly Newsletters

6. Carver Academy Elementary will provide each parent an individualized student report regarding the performance of their child on the state assessment in at least math, language arts and reading by:

- Student STAAR results will be made available through Skyward online. The school will provide computer access and guidance to assist the parents throughout the on line process.
- Progress reports are sent home once every six weeks.

7. Carver Academy Elementary will provide assistance to parents of children served by the school, as appropriate, on important topics. These may include, but are not limited to, the following:

- Reviewing and understanding the state's academic content standards.
- Reviewing and understanding the state's student academic achievement standards.
- Reviewing and understanding the state and local academic assessments including alternative assessments.
- The requirements of Title I, Part A.
- How to monitor their child's academic progress.
- How to work with educators.
- Other topics that received strong parent interest as reflected by the Title I school Parent Engagement Survey.
- Parents/teacher conferences.

8. Carver Academy Elementary will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using

technology, as appropriate, to foster parent engagement. These may include, but are not limited to, the following:

- Library Night/Literacy Night.
- Math Night.
- Science Night.
- Discovery Center Night.
- Skyward Parent Training.
- Parent engagement programs.
- Monthly Specials Night re: Piano, Vocal/ Spanish , Art, PE.
- 5th grade Parent Biome Meetings.

9. Carver Academy Elementary will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools. These efforts may include, but are not limited to, the following:

- Parent Involvement Support Team Training
- Annual Collaborative meeting to look at our specific campus Parent Engagement Plan to revise and improve our Parent Involvement.

10. Carver Academy Elementary will, to the extent feasible and appropriate, coordinate and integrate Title I parental engagement programs and activities with public preschool and other similar programs (e.g., Head Start, Parents as Teachers, etc.) that encourage and support parents in more fully participating in the education of their children. These efforts may include, but are not limited to, the following:

- Carver Academy Elementary does not have Pre-K or Kindergarten however Carver Early Childhood Academy does have new campus orientation for new parents of preschool programs. Parents can also turn to Carver Academy Elementary website for information regarding the campus.
- 1st grade has a program every year at Carver Academy to introduce the children and the parents to Carver Academy. The parents see their children perform with the Specials Classes offered and also the parents tour the campus to see the classes and Specials: Spanish, Art, Piano, Vocal Music and Environmental Science.

11. Carver Academy Elementary will take the following actions to ensure that information related to the school, parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand. These may include, but are not limited to, the following:

Interpreters will be available as needed. We do have parents or grandparents who may have limited skills regarding reading. These parents are assisted by Lynne Morris-Vivens (e.g., with completing paper work). Information is also communicated via phone calls, notes/newsletters and home visits.

PART III. Discretionary Components of the Carver Academy Elementary Title I Parent Engagement Plan
